- **Avoid Phishing Scams:** Always verify email addresses and avoid suspicious links. Contact the organization directly if unsure.

- **Secure Your Devices:** Keep antivirus software updated and avoid public Wi-Fi for financial transactions.
- **Shred Sensitive Documents:** Properly dispose of personal documents like bank statements and medical records.
- **Stay Informed:** Educate yourself about new security threats.
- **Use Secure Connections:** Ensure websites are secure before conducting transactions and avoid public computers.
